The Commentary Function of the English Progressive

- A Network of Properties of the Progressive Aspect

The English progressive is sometimes used in order to describe or comment on a preceding action or utterance. This commentary function is regarded as a special use of the progressive form because it shows properties that are not found in other uses of the progressive. The purpose of this article is to argue that this commentary function of the English progressive stems, not from the progressive having been derived from the gerundives, but from the network of properties of the progressive aspect; "duration", "incompleteness" and "temporariness".

Solubilization of Scale Collagen

TANIMOTO Shin-ya

The ways and degrees of solubilization of scale collagen were investigated.

Removal of hydroxylapatite did not affect to the solibilization of scale collagen.

The solubility in the absence of heating was up to approximately 27% even if enzyme hydrolysis was applied. Upon being heated up to a temperature of over 100°C, for 48 h, more than 90% of collagen protein was solubilized. 86% of this gelatinized soluble fraction showed that the molecular weight was less than 10,000. Meanwhile, heating for 24 h instead 48 h showed that about 90% of scale collagen protein was solubilized, and 73% of this gelatinized soluble fraction indicated that the molecular weight was more than 10,000.

It has already been indicated that schoolgirls in the Meiji period were using a masculine way of speaking such that "boku" (the masculine pronoun of the first person) and "kimi" (the masculine pronoun of the second person) were used. In this article, the author demonstrates some new examples of this way of speaking

from 'the Daily Yomiuri'.

On the other hand, schoolgirls in the Meiji period were using a unique way of speaking that had the characteristic ending called "dawa" and "teyo" etc. Necessarily, this way of speaking did not match traditional feminacy and often became the object of criticism. The author shows from 'Jogakuzasshi' several examples of how this unique schoolgirl way of speaking was used and points out that the users deviated from traditional feminacy.

There is a theory that this unique schoolgirl way of speaking was the way of speaking of the geisha, but so far this has not been demonstrated. The author shows from 'the Daily Yomiuri' several actual examples that geishas were passing to the girls' school and discusses the possibility that the way of speaking of the geisha actually influenced schoolgirls.
