Summary

"Stage Model" Metonymy: An Investigation on the Causative/ Inchoative Alternation of the English Verb "Break"

The English verb "break" is one of a group of verbs with "causative/inchoative alternations," which are often explained by the "Unaccusative Hypothesis." The hypothesis stipulates that the inchoative use of "break" is possible when the implicit causing event is left completely unspecified. We argue that the alterations reflect the construal of an event by a coneptualizer, and that "stage model metonymy," a cognitive-based hypothesis proposed herein, can give a unified account of the whole renge of "break" alternations.

Maria Montessori was born in the urban community of Chiaravalle, in the suburbs of Ancona, in the province of Marche in a historical age of upheaval, when Italy was beginning to take steps as an independent, modern nation. In this paper, in Accordance with practice items of the "New Sports Test" issued by the Ministry of Eductation, Culture, Sports, Science and Technology, we report and consider Students of AJC poll results on physical examination and 6 items of sports test for the 5 years since 2000, and projected future tendencies. Furthermore, we examined body fat rate and health opinion.

Our conclusion is that Students of AJC have (1) the urban type of body from, (2) almost appropriate body fat rate, (3) no inferiority in sports tests compared to other groups, but (4) no confidence in sports owing to less physical practice, (5) rather strong need of physical practice.

Cooperation between Feminism and Natural Law Theory—Seeking an Alternative Framework of Law and Ethics

Feminism has been a strong movement against modern concepts of freedom and justice. It criticizes and deconstructs modernism vigorously, but it does not propose an alternative framework. Paradoxically, this attitude may leave women oppressed. Christina L. H. Traina suggests that in order to fulfill its own project, feminism should turn from "the feminist critique" into "a feminist ethics," and "must pay serious attention to natural law" to do so. Following Traina, I investigate the basic compo-

nents of feminism first, and the possibilities and limits of feminist epistemology and anthropology, which are the foundation of the components next. Then, in order to reinforce them, I examine main ideas of the traditional Thomistic natural law theory, that is, "the virtue of prudence" and "human goods" derived from the ultimate end. Feminism and natural law theory should cooperate to construct an alternative framework of law and ethics for human (or women's) flourishing. Seeking more fruitful cooperation, we should examine Finnis-Grisez natural law theory more, which Traina denies lightly.
